* Officiating games in a highly competitive AAU tournament with qualified clinician on hand to evaluate you're officiating. This tournament is in conjunction with the NCAA recruiting period and several college coaches from WI, MN, IA & IL will be in attendance.

* Several games will be video taped with a clinician narrating the action for critiquing and feedback.
